Summer Private Instruction Registration Form for Current Students

Priority Deadline: May 15, 2021

Summer Session: June 15 – September 5, 2021

It's time to start planning for summer lessons! For the benefit of your/your child's studies, we strongly recommend that lessons continue during the summer. This continuity is essential to maintaining effective practice routines over the three-month summer period. In contrast, prolonged interruption of lessons typically results in spending much of fall semester recovering lost skills.

HOW TO SIGN UP FOR THE SUMMER SESSION:

1. Bring this form to a lesson to discuss with your/your child's private teacher.
2. Collaborate with your/your child's private instructor to plan a summer learning strategy: goals, lesson days, lesson times, lesson length, etc. (please consider vacations and camps when coordinating schedules).
3. After consulting with your teacher, fill out the information on the back of this page with the schedule discussed with your private instructor indicating specific days, lesson length, and the total number of lessons. If you do not have any make-up lessons from spring semester, check with your teacher to see if you may schedule your first summer lesson during spring make-up week.
4. Once completed, **submit this form** to your Campus Staff, who can help you calculate your summer balance due. **Payment is due in full at the time of registration.**

PLEASE NOTE:

- **Payment is due in full at the time of registration.**
- If you are not certain of your complete summer schedule at this time, please register for the weeks for which you are certain; you may always add additional lessons later in the summer.
- Financial aid is available for summer private instruction for students currently receiving financial aid; please request continuation of aid on other side of this form.
- Make-up lessons are not offered during summer session due to the personalized customization of each student's schedule.
- Refunds are not given in the event of missed lessons.
